

### March Speaker—Post Member Tom Hallums



Tom was a combat medic in Korea. I didn't realize those guys went through so much training, even though my dad was a medic. Tom took us on a journey from TN to Ft. Lewis to Korea. He is the one guy I know that enjoyed train rides, boat rides, and seeing the world. Tom's first combat experience was retrieving three soldiers who had been wounded in a rice patty. As Tom tells the story, he went and got them. Somehow there must be a bit more to the story since he received the Silver Star for his actions that day. Not bad for your first day in combat. Like most of us who served, Tom said his service changed his life and I gather mostly for the good. Tom

spent a year in Korea including going north to the Yellow River and then south after the Chinese invaded Korea. Tom is a great Post member and it is obvious from his service that he was a great medic. Those guys didn't get paid enough for what they did (and what they do today).

#### The Last Word

[I apologize for the short newsletter this month. I think most of you know I'm a CPA. As I sit here and type this, I am looking at mounds of returns waiting for my attention. However, I wrote most of this "Last Word" while I was watching a newscast about of a death of veteran.]

Frank Buckles, the last surviving WWI veteran, died in March at the age of I I 0. In the I 950's, I remember going on vacation with my best friend, Gary, and visiting his uncle who was sucking oxygen when we stopped to visit him in Portland. He had been gassed in the trenches in WWI, and I guess he was the only combat vet I met from the "Great War". At about the same time, TV came to Yakima and I recall seeing the Civil War vets in the open limousines in NY at the Armistice Day parades. Generations come and go and are soon forgotten by those who come behind. So I salute an end of a generation of warriors while I look at another shrinking generation of veterans whom I hold in the deepest respect, those from WWII. Each generation of veterans has left its legacy to this country. It is up to us to make sure that those who came before us are never forgotten.

The family of Frank Buckles wished to have his body reside in the Capital Rotunda in Washington DC. That viewing was denied. As far as I can see in my research, other than 4 or 5 star generals and Presidents who served in the military, the only veterans to have their bodies reside there are the unknown soldiers from WWI, WWII, and Vietnam (who was later identified). However, there have been a number of politicians given that honor after their deaths. Perhaps its just my background, but I would have given my permission to the family had I been in charge. There should be some reward for being the last man standing.
